## **Summary:**

I have been qualified and registered as an art therapist since 1983 and State Registered since 1998.

My area of special interest is the "borderline" between art psychotherapy and the uses of "art as therapy". My working practice involved managing a voluntary sector community-based service which provided both approaches, in the area of adult mental health.

My clinical work has focussed on working with people whose problems require long term support; these issues cover sexual abuse, drug and alcohol abuse and the effects of emotional and social deprivation.

I also have experience of providing services which involve the more public, and political, use of the arts, as a means of promoting the interests and views of people who are marginalised by disadvantage or disability.

The other important area of experience for me is work as a tutor, facilitator and training supervisor in education in art therapy and in mental health and community care issues.
